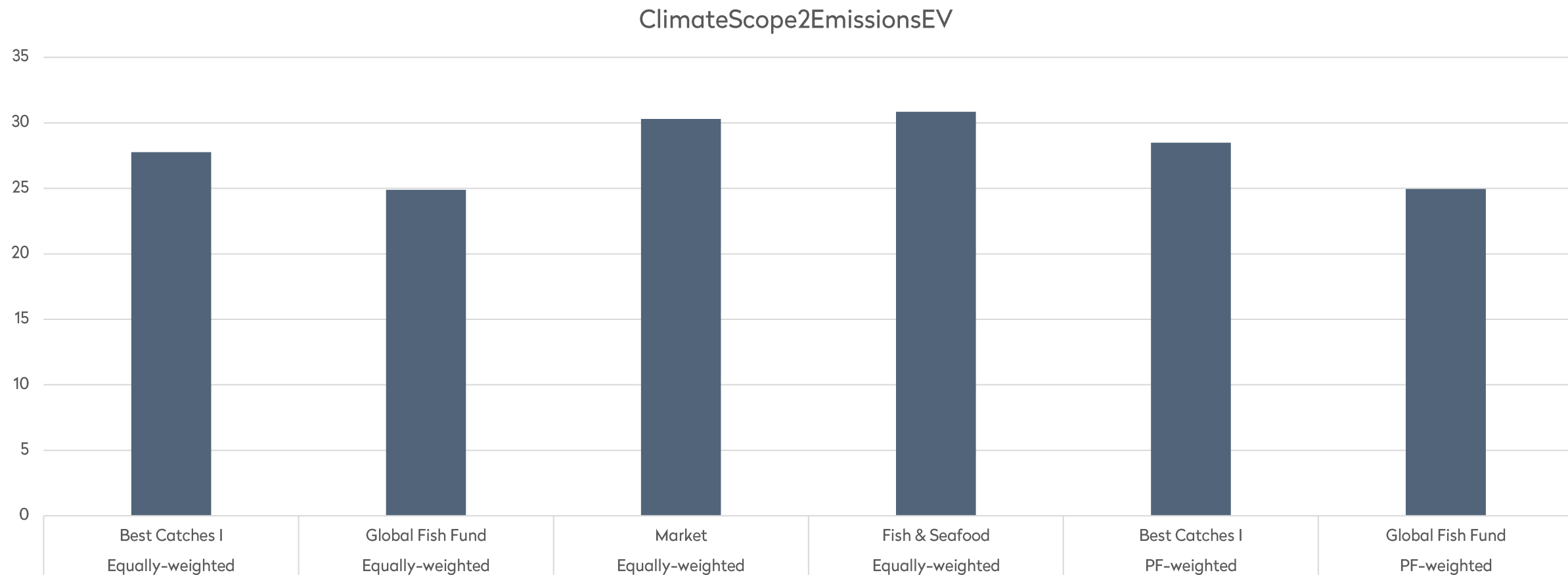

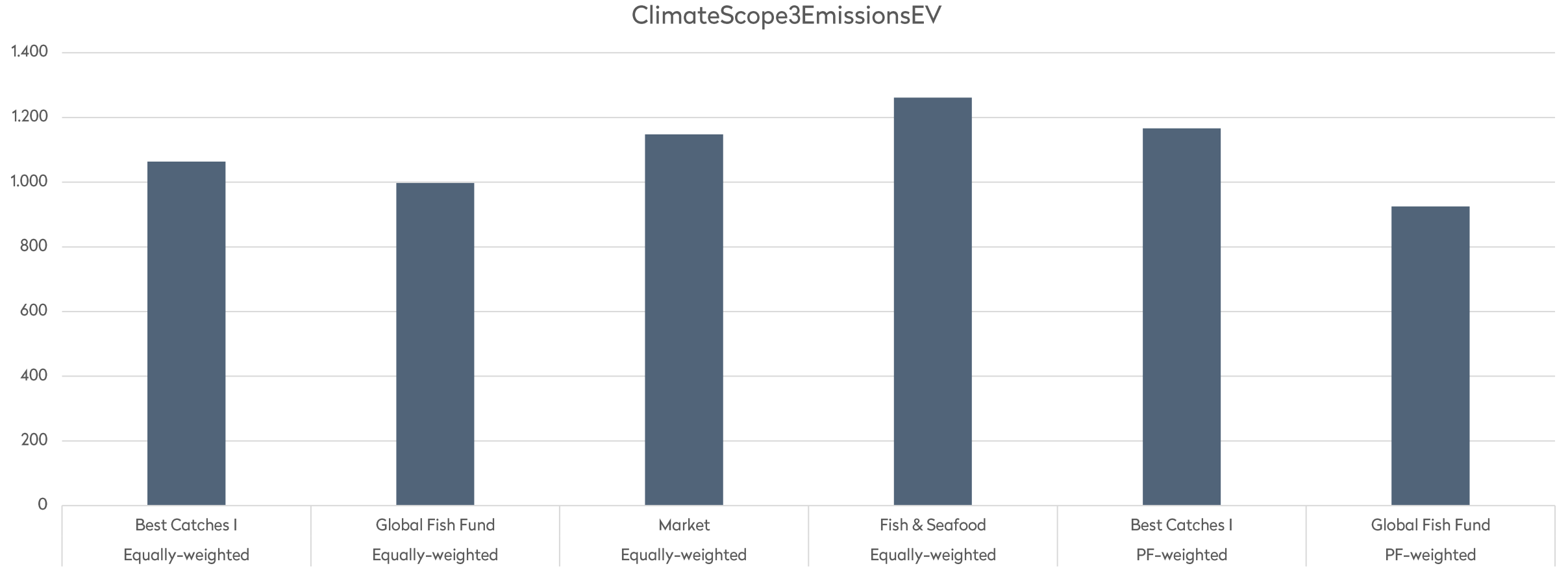
Tonnes of scope 1 per Mio EUR Enterprise Value

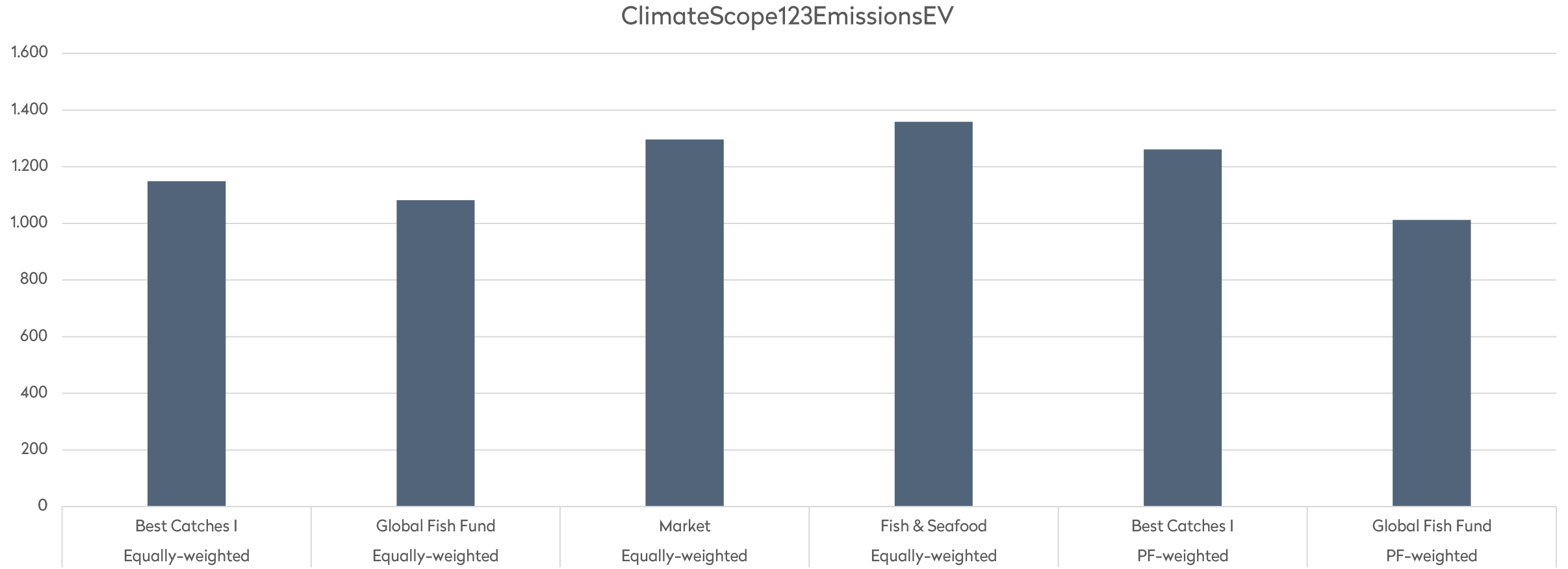
Tonnes of scope 2 per Mio EUR Enterprise Value

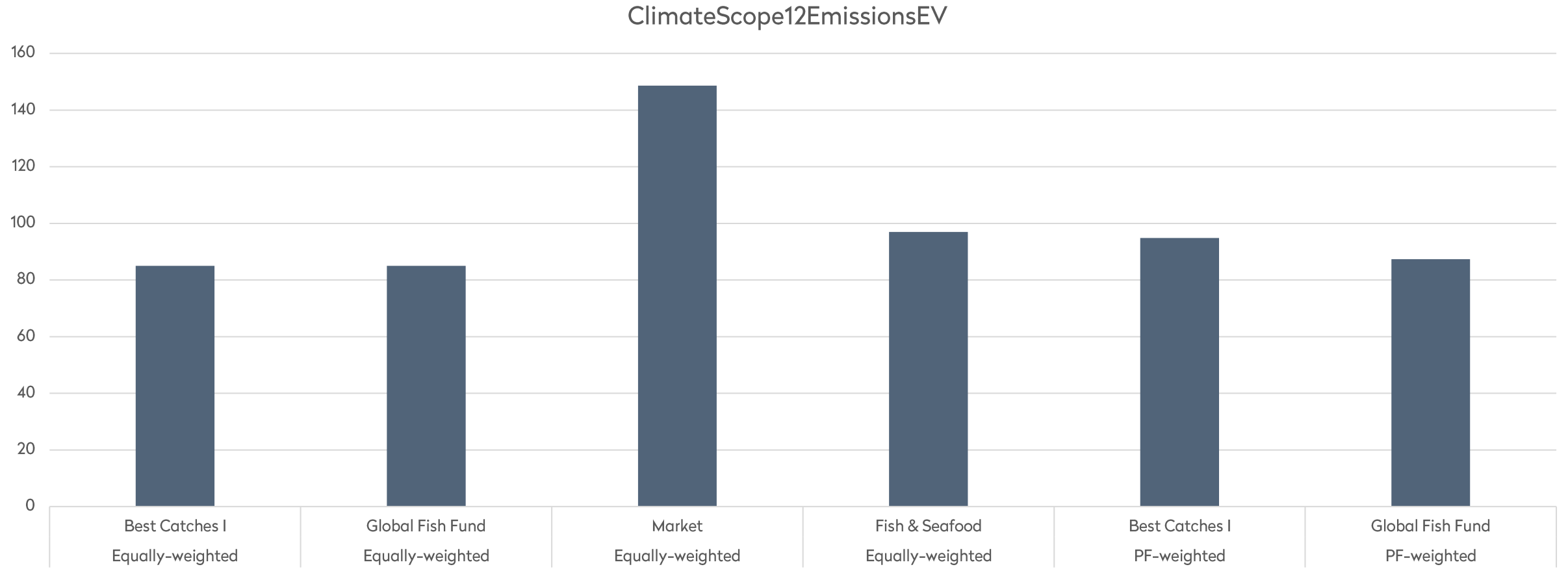
Tonnes of scope 3 per Mio EUR Enterprise Value

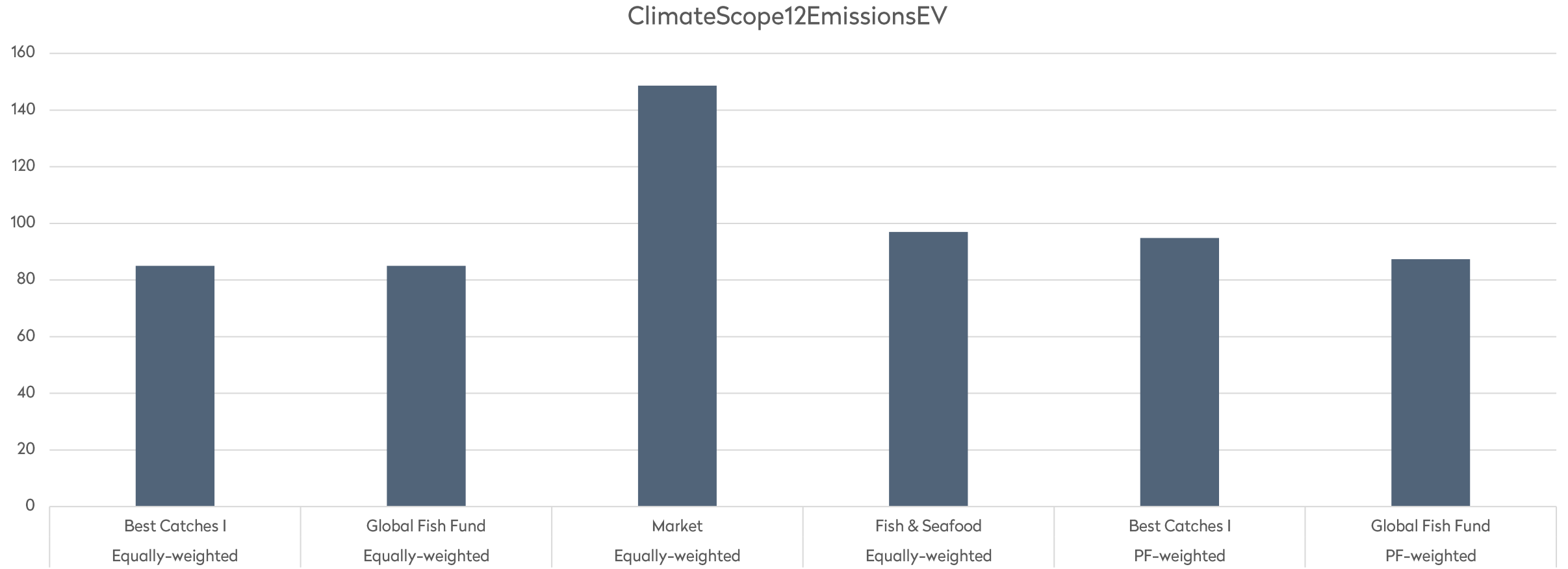
Tonnes of scope 1+2+3 per Mio EUR Enterprise Value

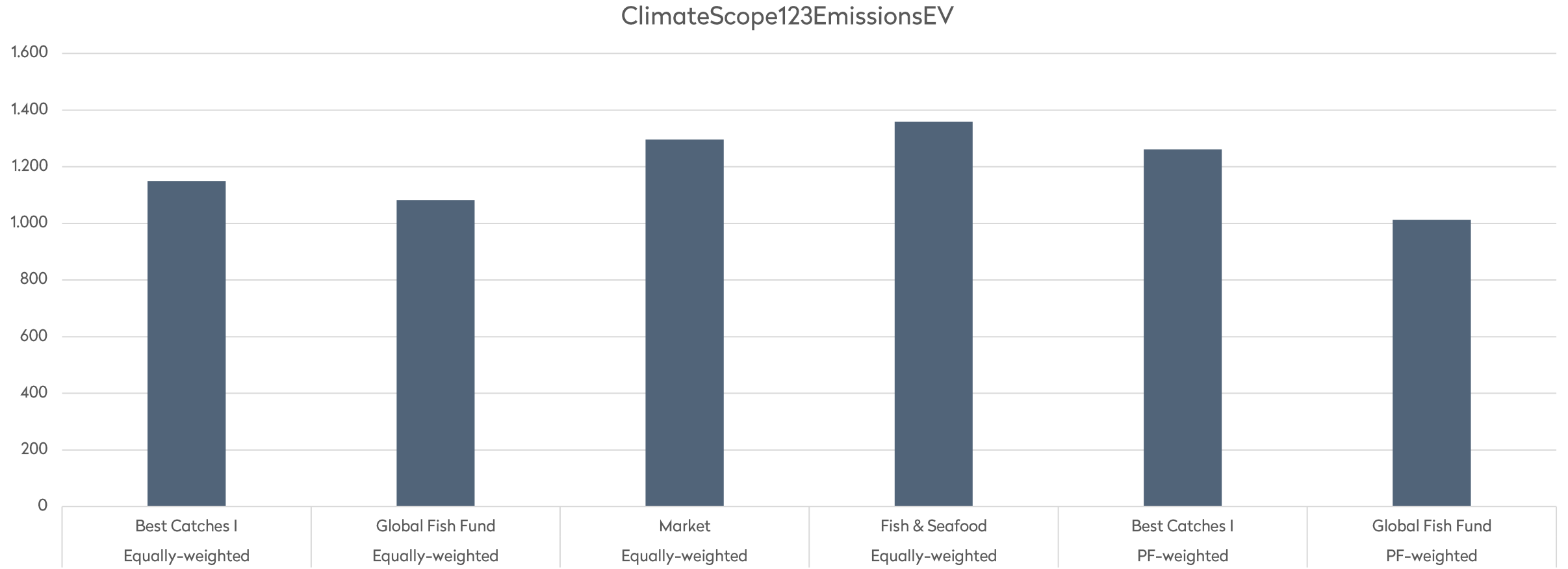

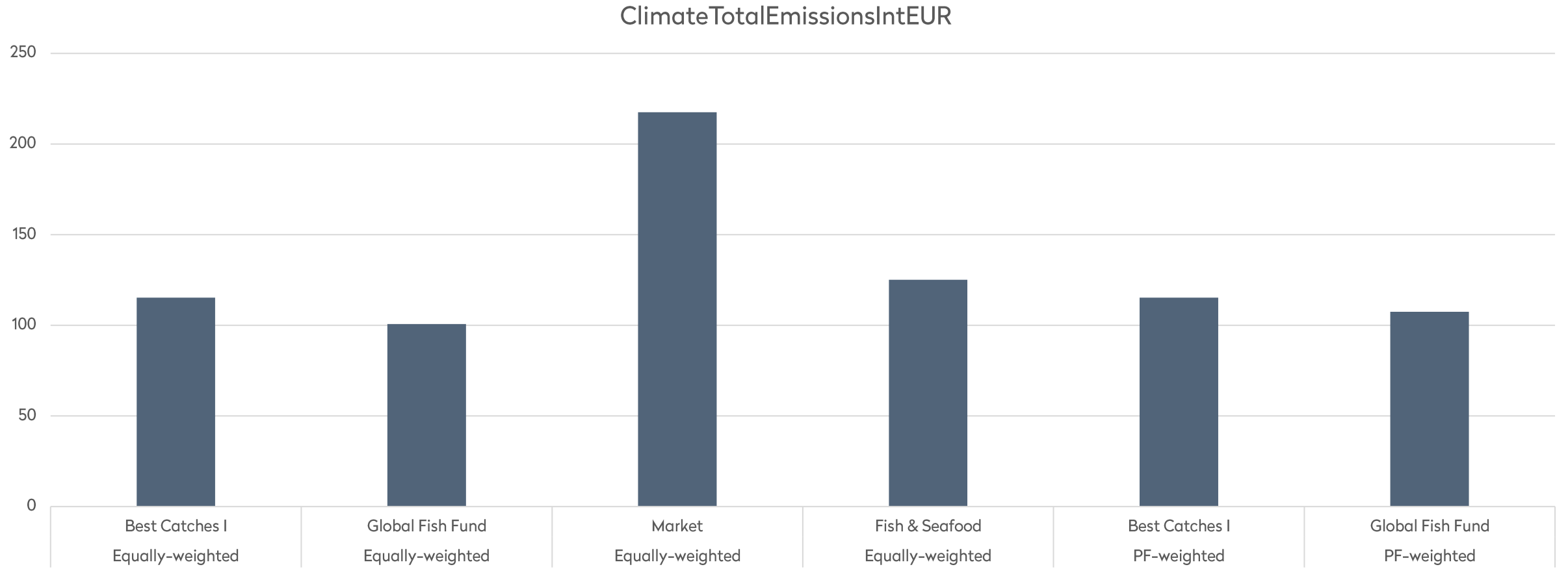

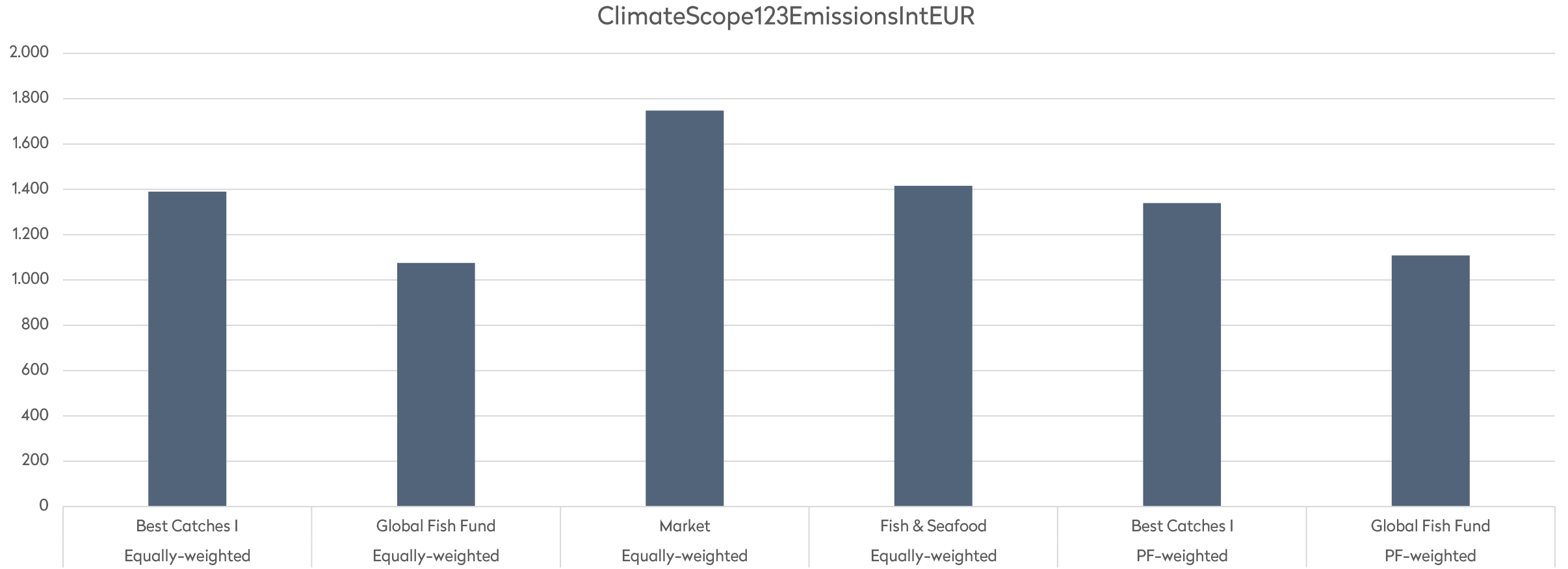

GHG intensity of investee companies



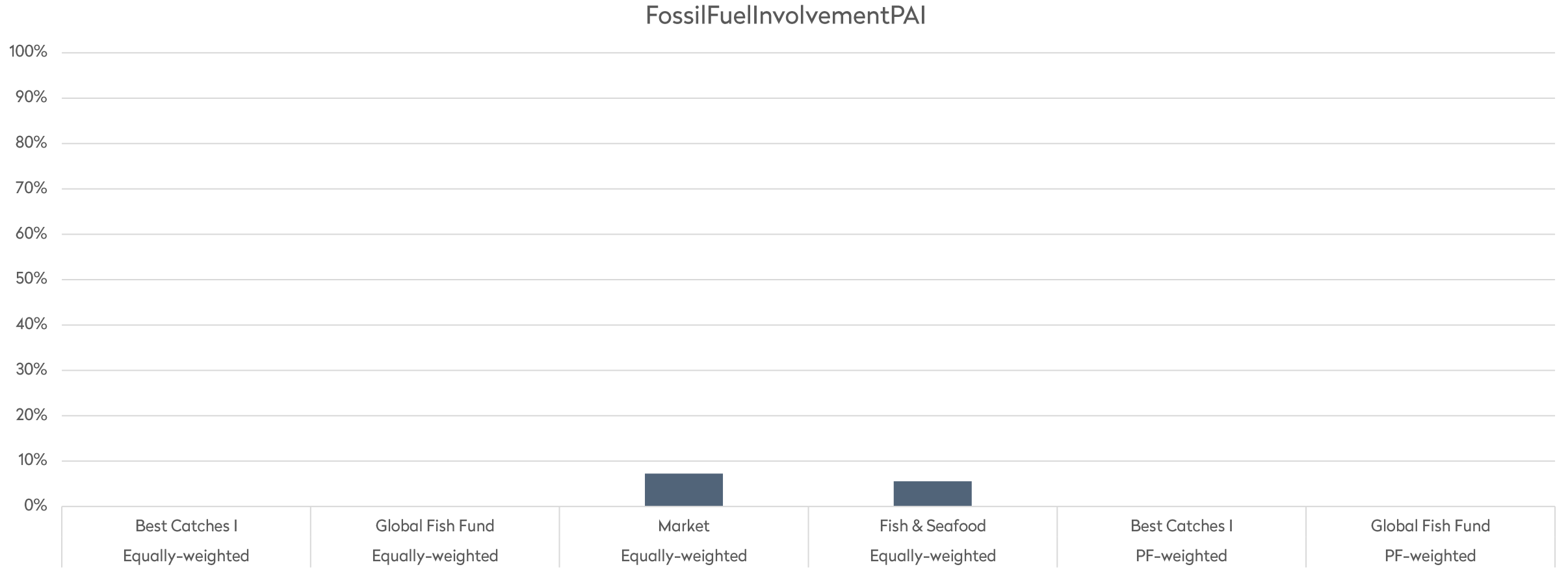
Tonnes of scope 1+2 per Mio EUR Revenue

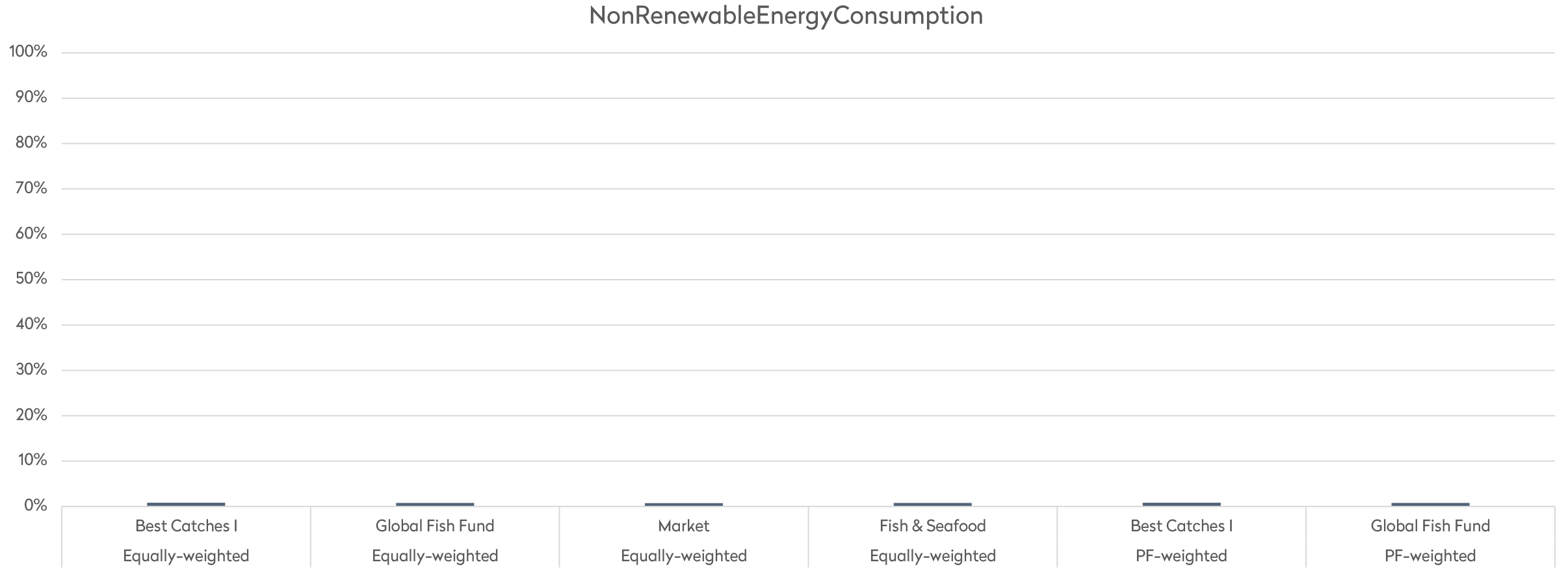

Exposure to companies active in the fossil fuel sector



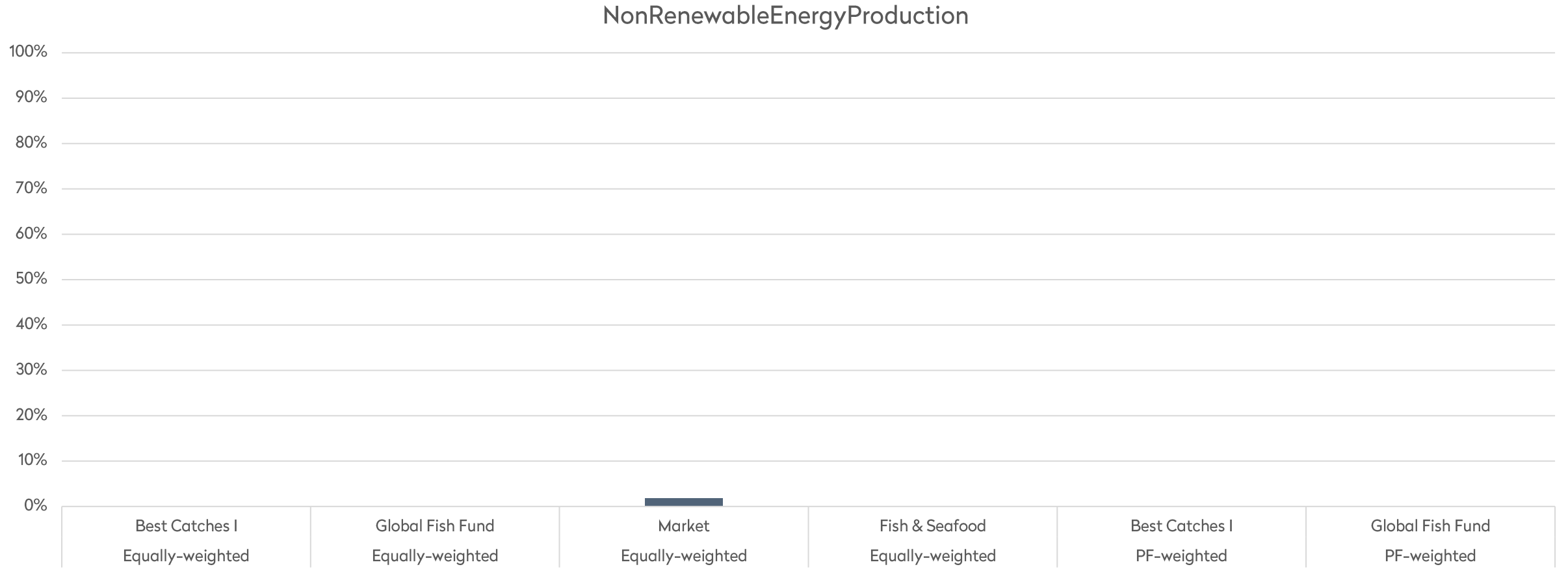
Share of investments in companies active in the fossil fuel sector

Share of non-renewable energy consumption and production



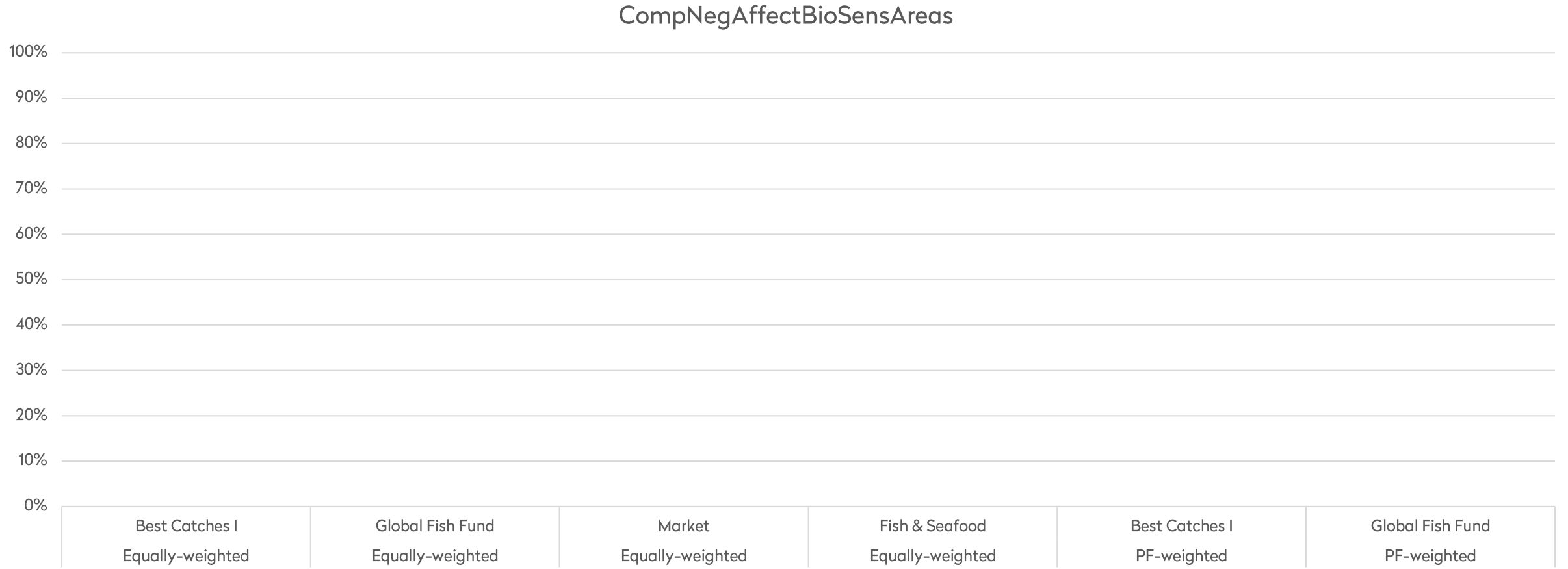
Share of energy consumption from coal, nuclear, oil, natural gas, waste-to-energy, biomass or unclear energy sources

Share of non-renewable energy consumption and production



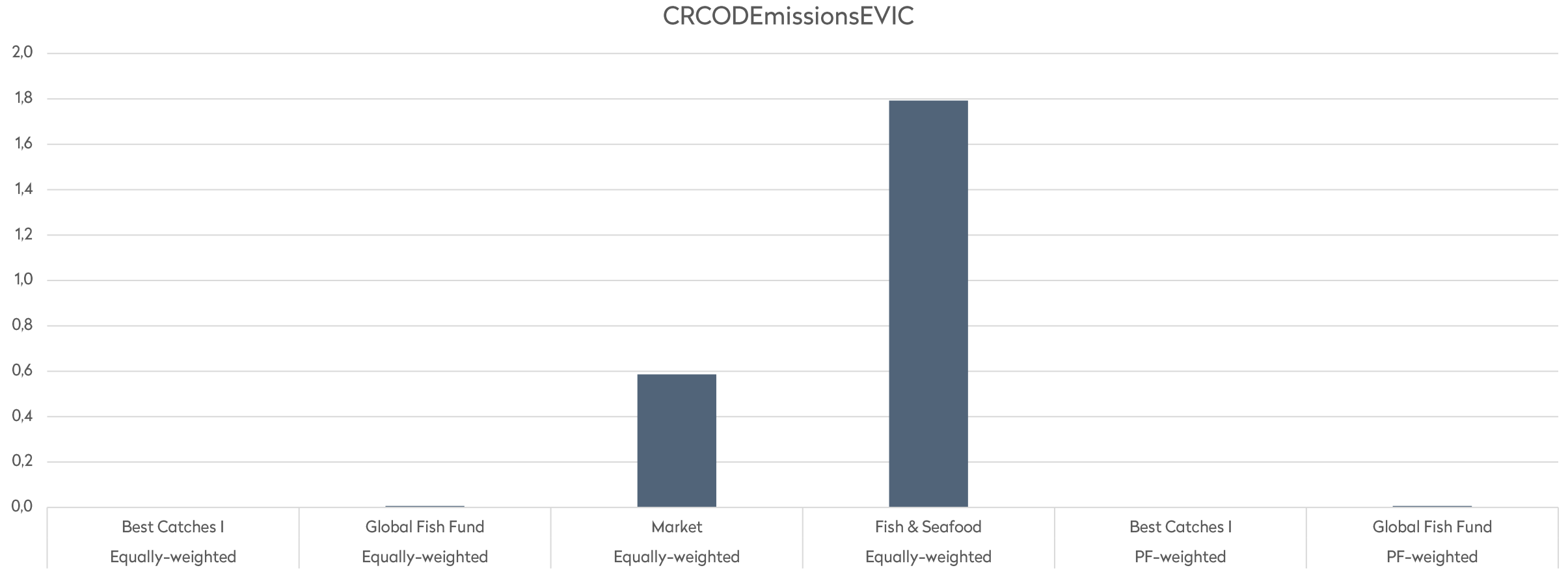
Share of non-renewable energy production of investee companies from non-renewable energy sources

Activities negatively affecting biodiversity-sensitive areas



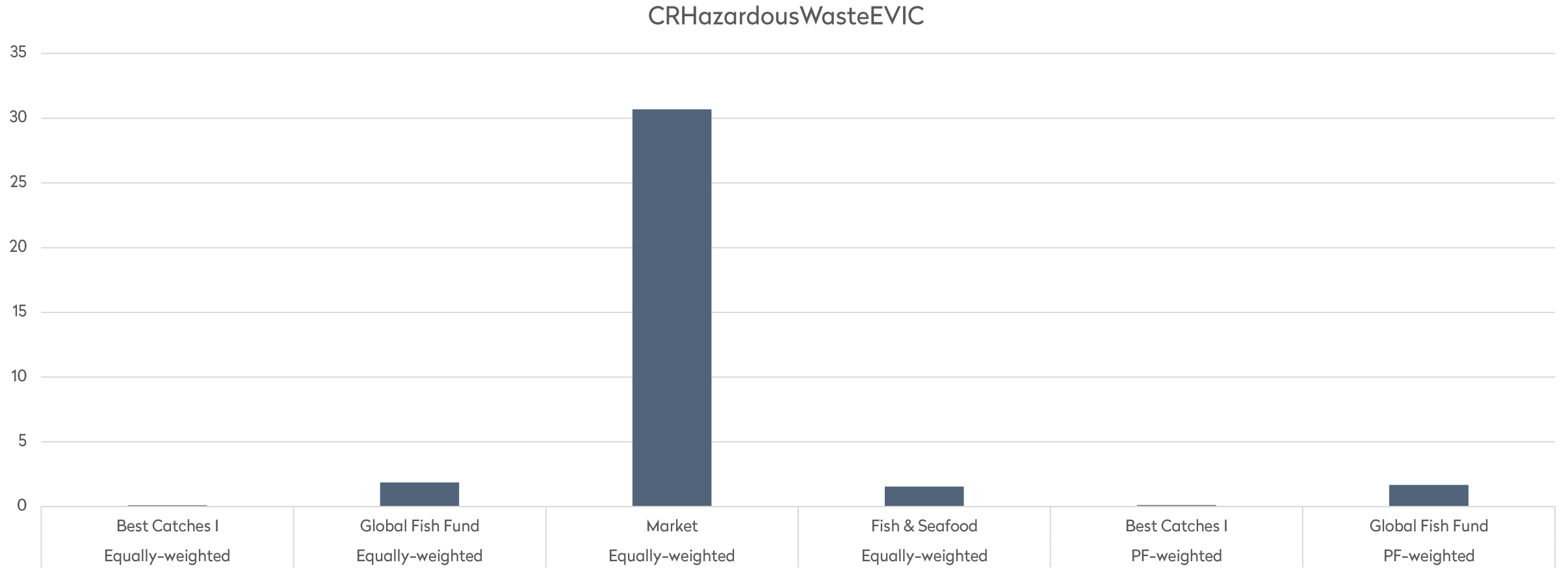
Share of investments in investee companies directly involved in controversies which negatively affect biodiversity-sensitive areas and where remedial measures have not been implemented

Tonnes of hazardous waste generated by investee companies per million EUR invested based on the companies' own definitions

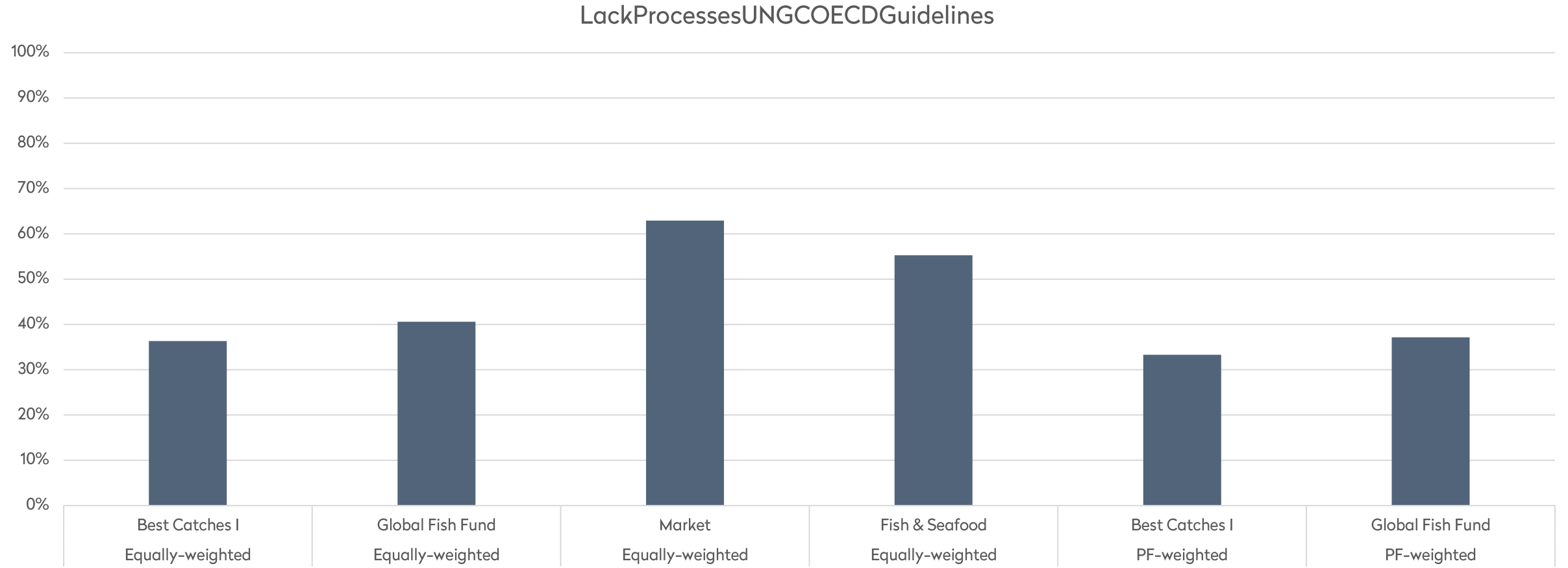

Share of investments in investee companies that have been involved in violations of the UNGC principles or OECD Guidelines for Multinational Enterprises

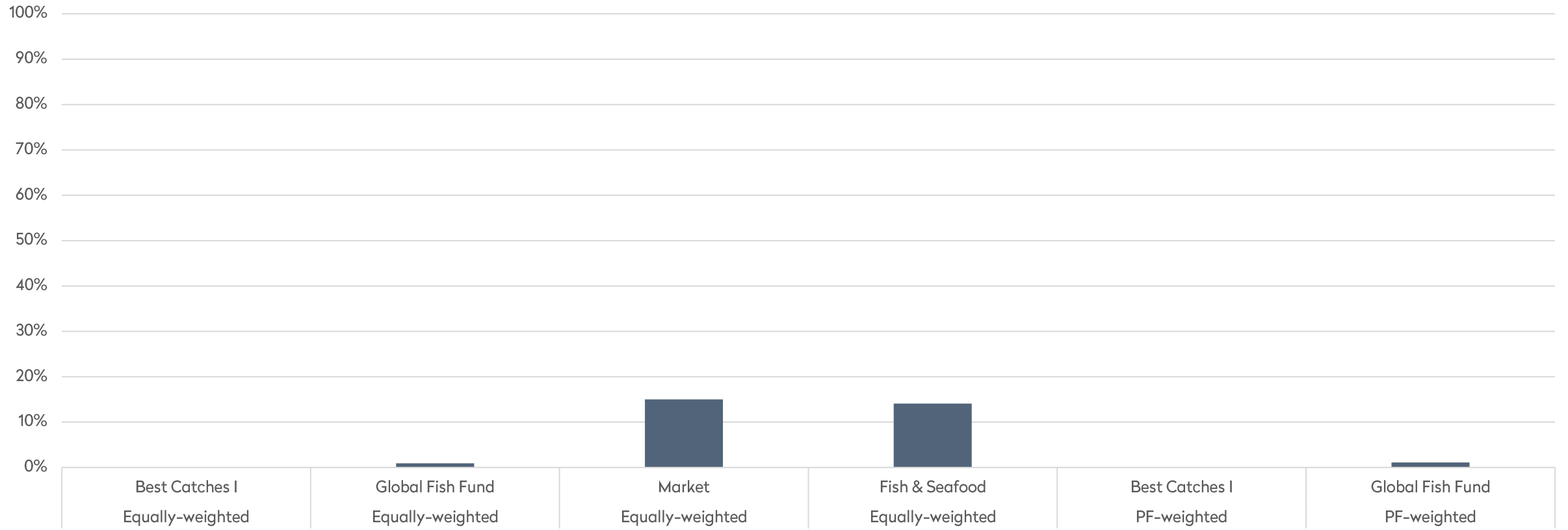

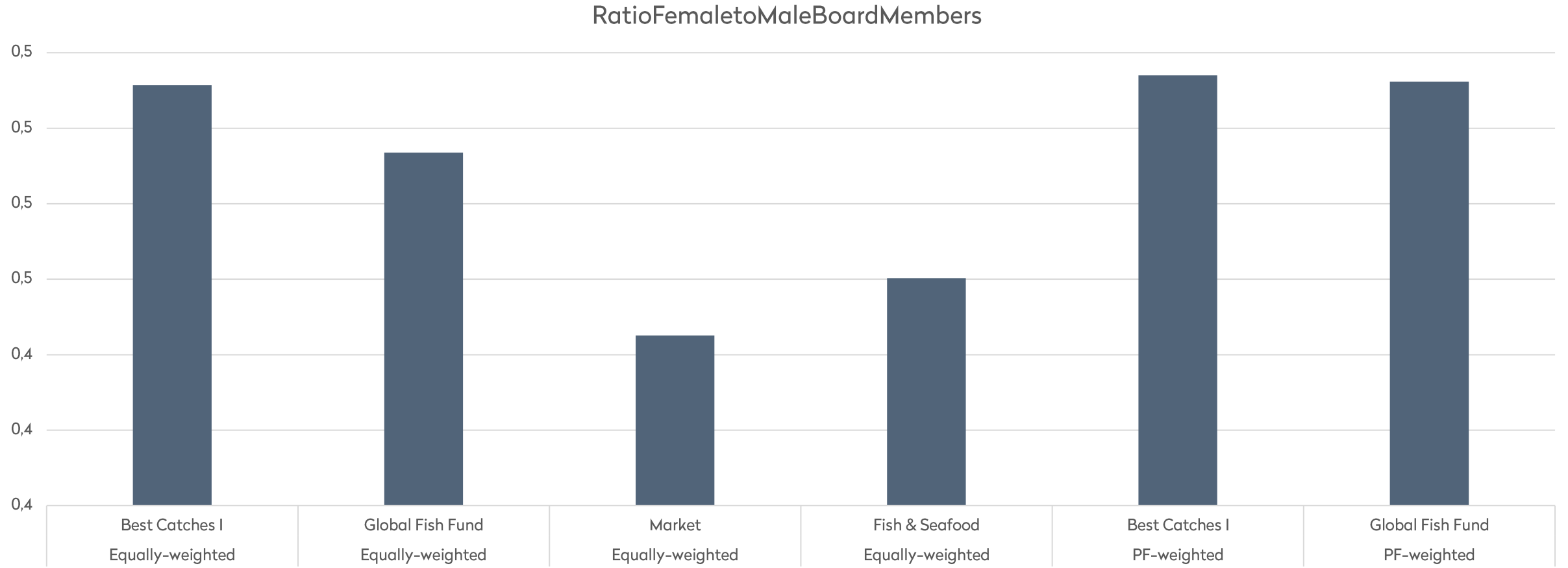

Exposure to controversial weapons (anti-personnel mines, cluster munitions, chemical weapons and biological weapons)

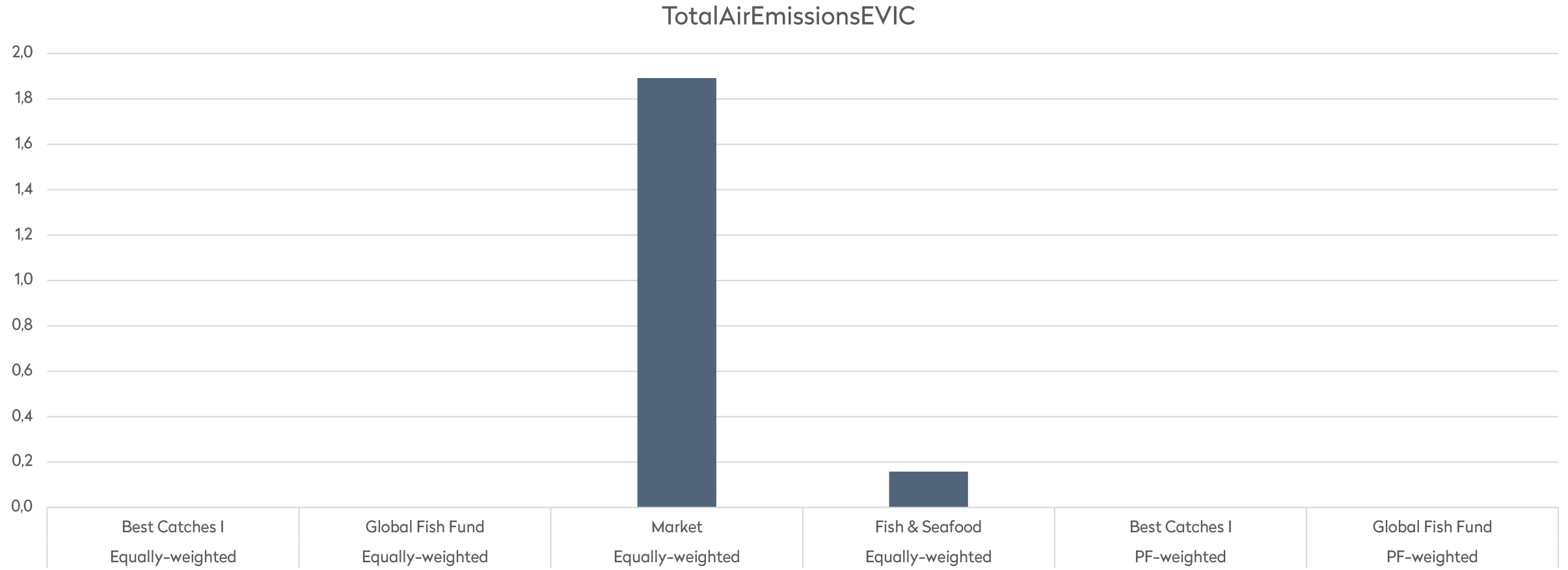

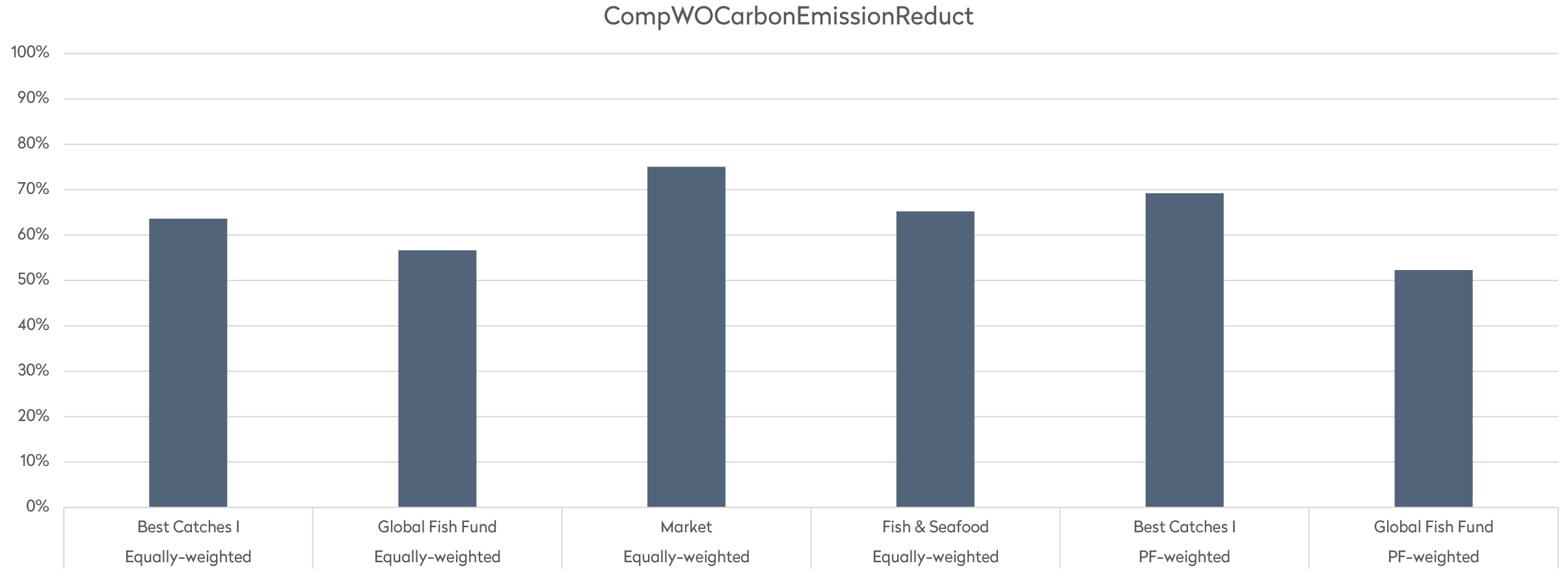


Emissions of air pollutants



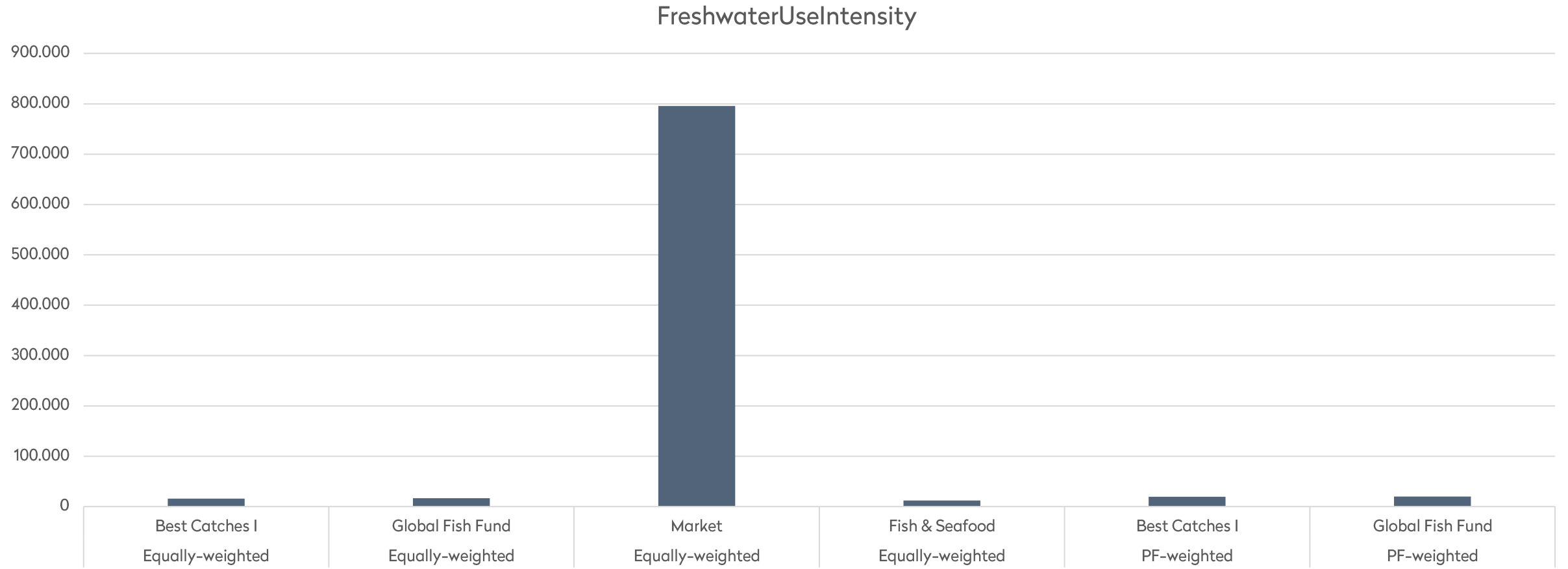

Investing in companies without carbon emission reduction initiatives



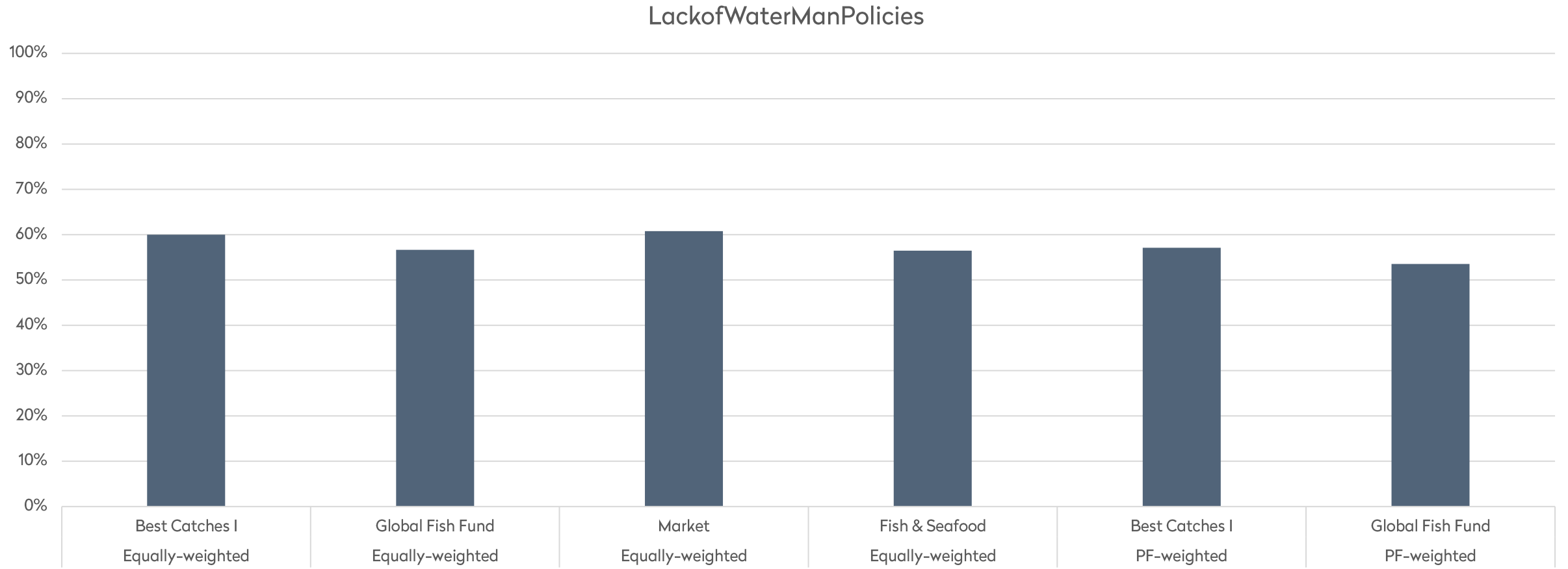
Share of investments in investee companies without carbon emission reduction initiatives aimed at aligning with the Paris Agreement and approved by the SBTi

Water usage and recycling



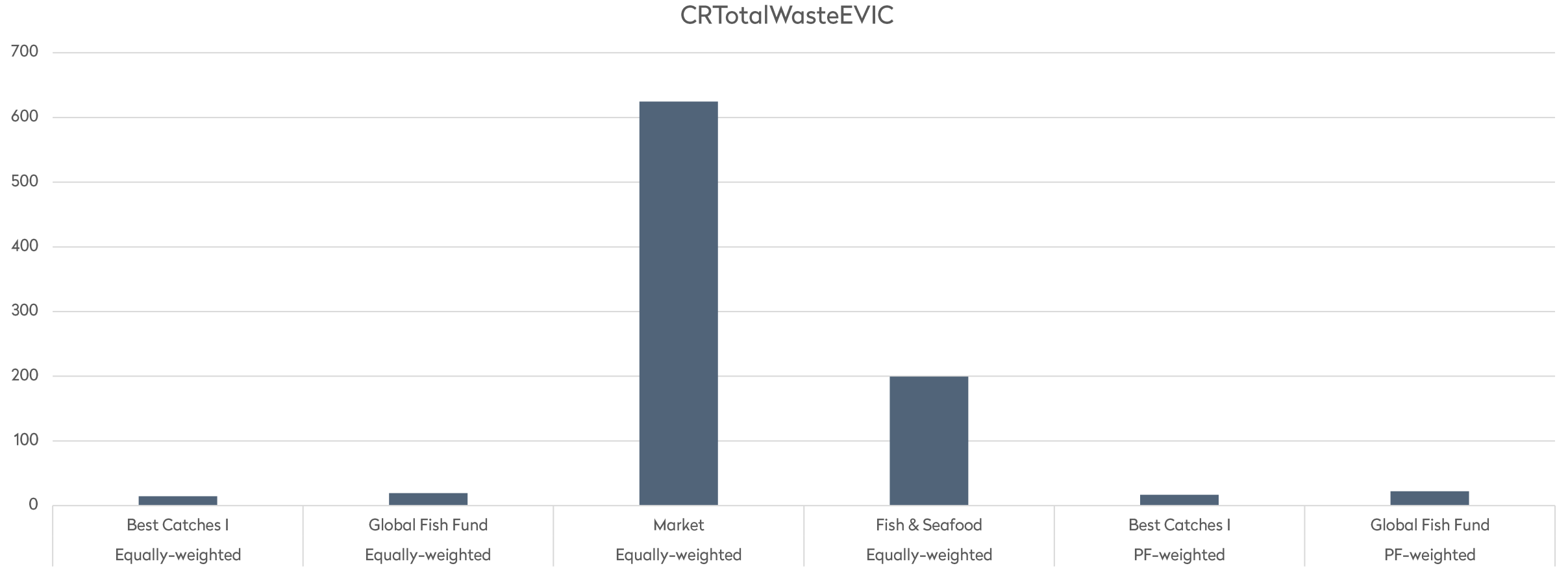
Average amount of freshwater consumed by the investee companies (in cubic meter) per million EUR of revenue (reclaimed water is not taken into account)

Tonnes of total waste (recycled and nonrecycled) generated by investee companies per million EUR invested

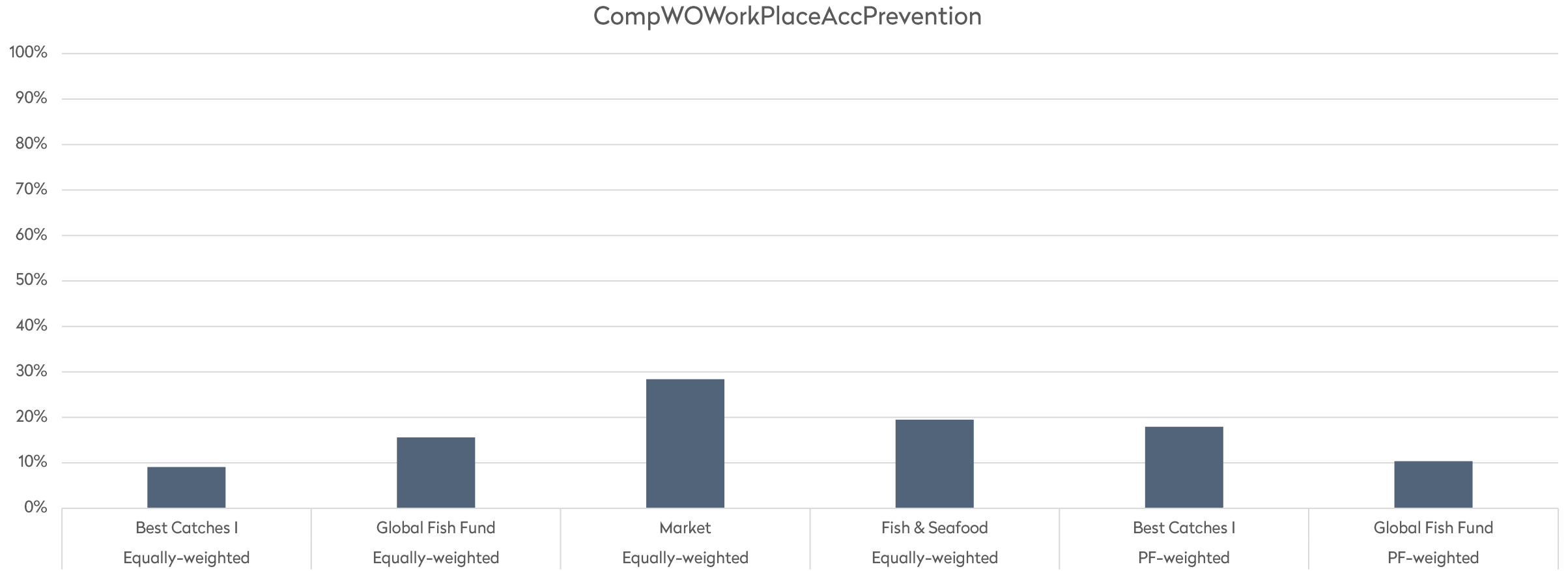

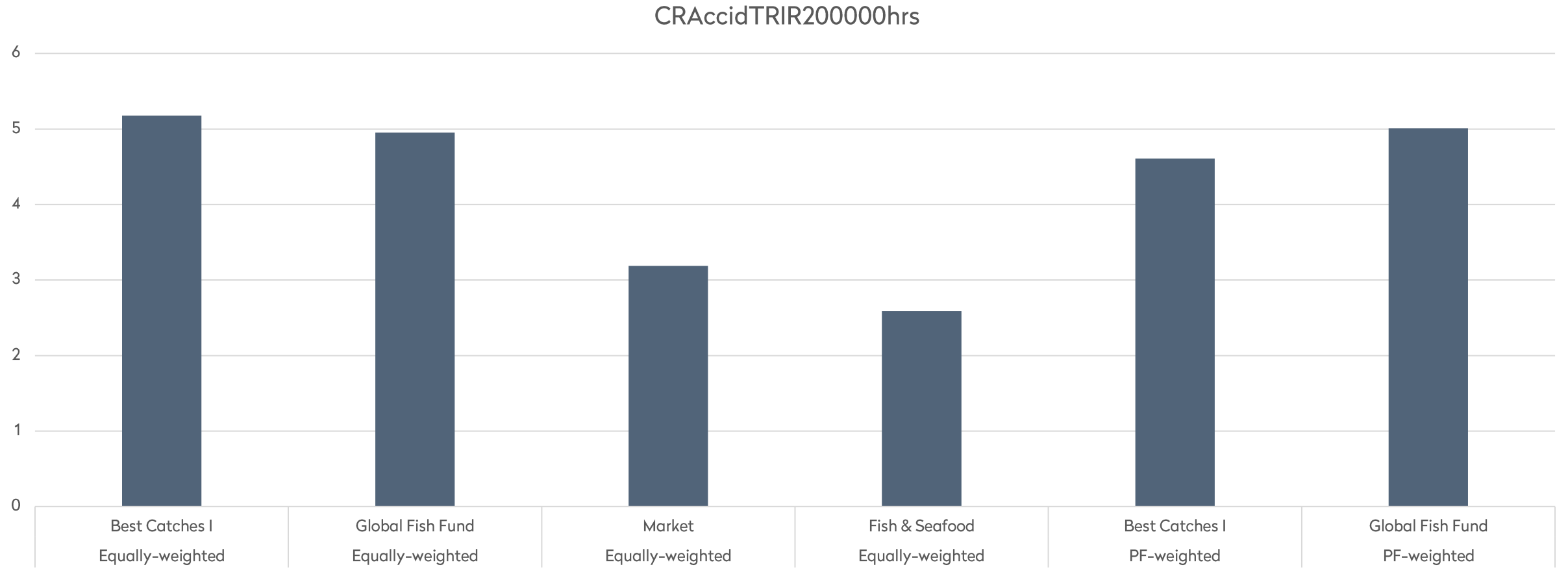

Investments in companies without workplace accident prevention policies



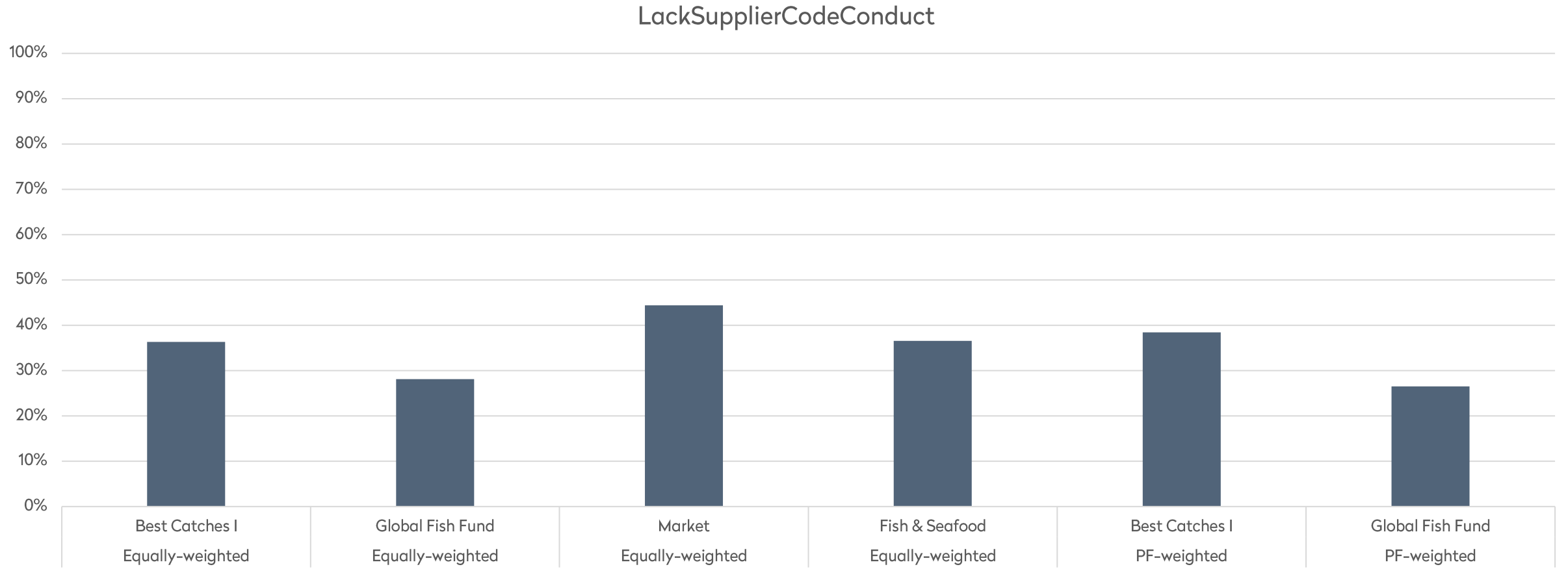
Share of investments in investee companies without a workplace accident prevention policy

Rate of accidents



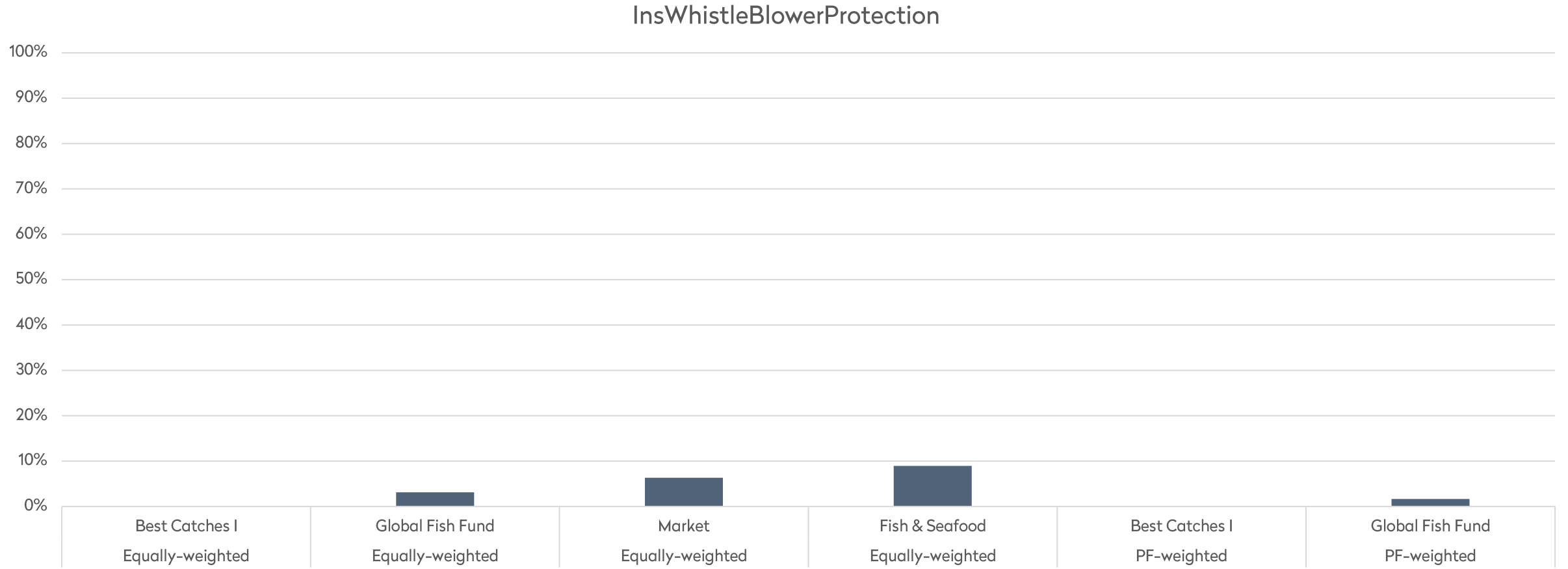
Rate of accidents in investee companies per 200.000 working hours expressed as a weighted average

Lack of a supplier code of conduct



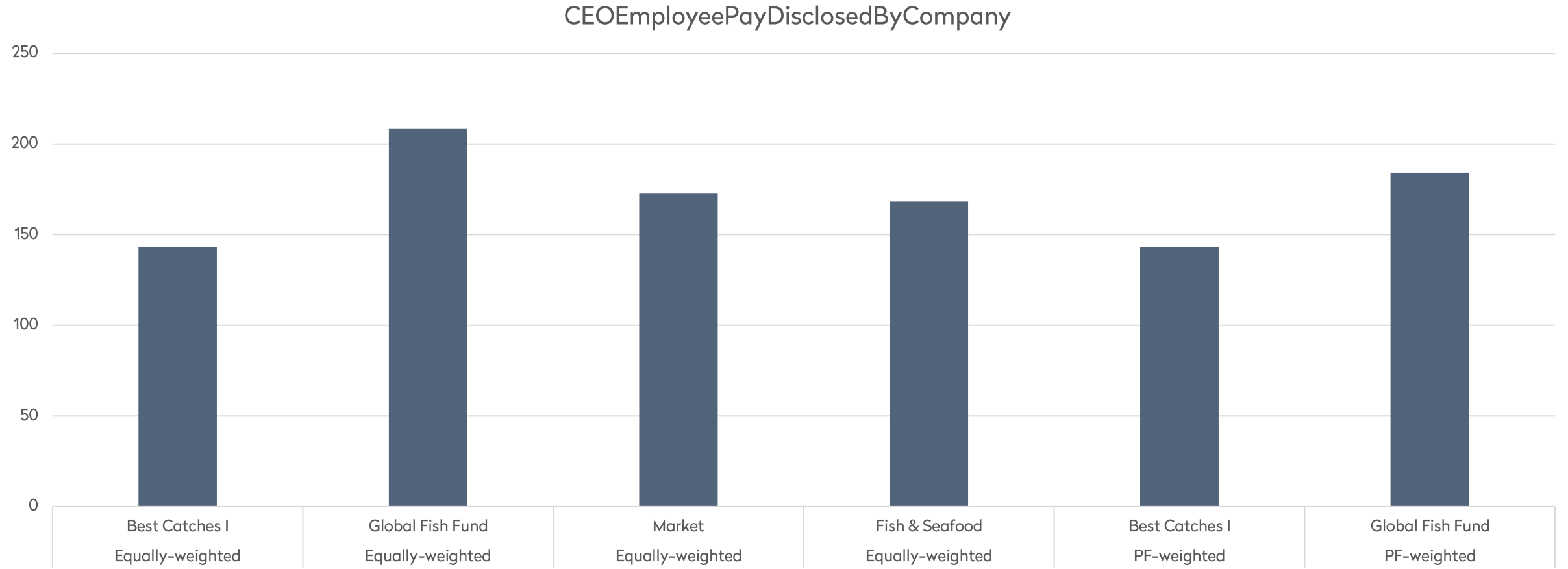
Share of investments in investee companies without any supplier code of conduct (against unsafe working conditions, precarious work, child labour and forced labour)

Insufficient whistleblower protection



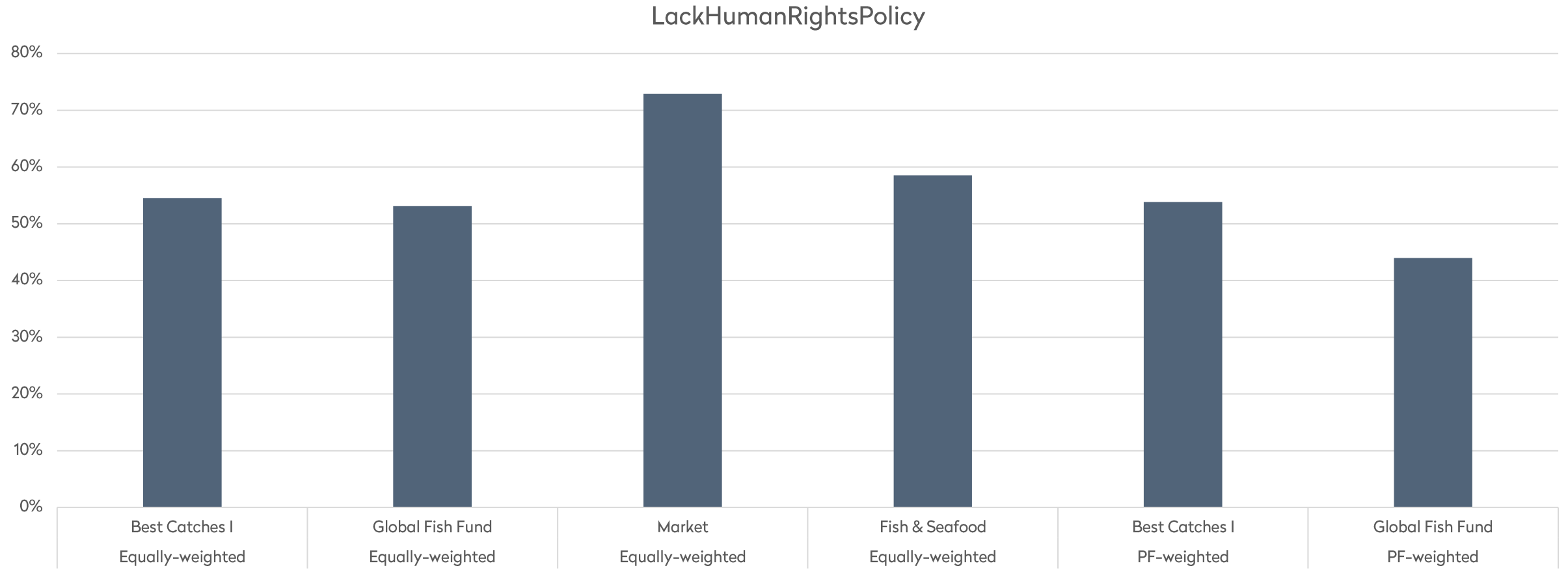
Share of investments in entities without policies on the protection of whistleblowers and the existence of a confidential hotline

Excessive CEO pay ratio



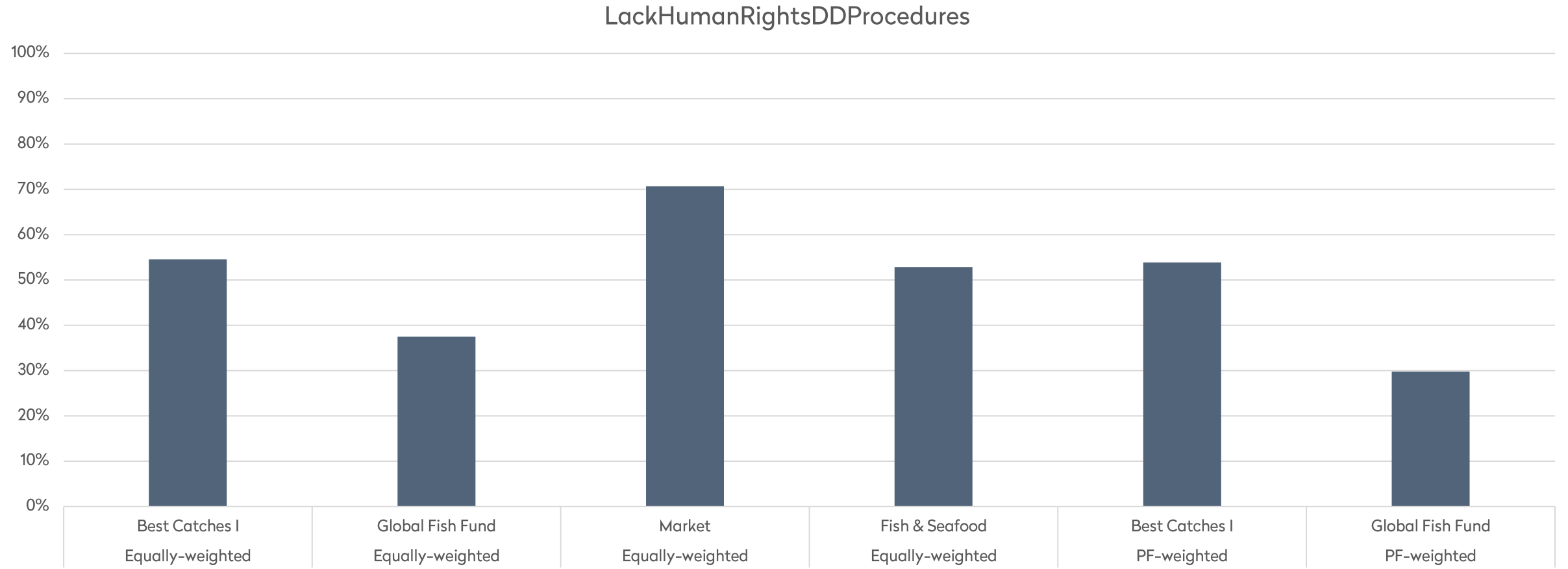
Average ratio within investee companies of the annual total compensation for the CEO to the median annual total compensation for all employees
